### Overview

**Hondros Crossing** is a 6.4 acre mixed-use development located in Westerville, Ohio that is being developed by Christoff Land & Development, LLC.

The project owned by Christoff & Hondros Family includes leasable space of approximately 6,500 square feet of retail/restaurant space sitting on 1.909 acres. The building will be constructed on the northern most side of Hamilton Road with over 247' of frontage. Future phases include retail, restaurant, medical, and office related uses.

The steel frame structure consist of metal, brick, stone, glass and storefront-style facade on all four sides of the external skin with building overhangs (protect pedestrians from the elements), energy efficient LED/ fluorescent lighting, white roof and roof insulation.

The building is surrounded to the south, east and west with sidewalks extending the length of the building inviting pedestrian access to the building entrances, outdoor patio, rear parking and future adjacent development areas.

Drive and Parking cross easements are provided across the entire master plan to insure the designed function of the parking and internal vehicular circulation system is accessible across all Sub-Areas.

The proposed restaurant space will include an outdoor patio engaging the public space around the property. The patio area will be equipped with optional garage door(s) or movable glass enclosures which will allow the patio area to be opened or closed through the cooler months of the year.

**Lot 1:** (Zoned C-4) **Leasing (Building 1)** – Christoff will be constructing up to +/-6,500 square feet of retail on this subarea. Lot 1 is located on the north side of Hamilton Road with over 247’ of frontage on Hamilton Road. The building will be pulled toward the sidewalks, providing a "hard line" interface with the street so businesses are oriented towards the street (Hamilton Road).

**Lot 2:** (Zoned C-4) **Leasing (Building 2)** – Christoff will be constructing up to +/-40,000 square feet mixed-use three story building with rooftop. This prime signalized corner ground sits on Warner road and Hamilton road and is available for lease to a Retailer, Restaurateur, Fast Food, Medical, Bank, Grocery store user.

**Lot 3:** (Zoned C-2) **Fully Leased (Building 3)** – Christoff will be constructing up to +/-5,700 square feet of retail on this subarea. This beautiful scenic site is contiguous to Rocky Fork Creek with approximately 2.6 acres allocated as a Conservation Easement area with Open Space corresponding to the 100 year flood plain of Rocky Fork Creek.

**Lot 4:** Christoff will Donate Rocky Fork Creek Land to City of Columbus (Parks & Recs)

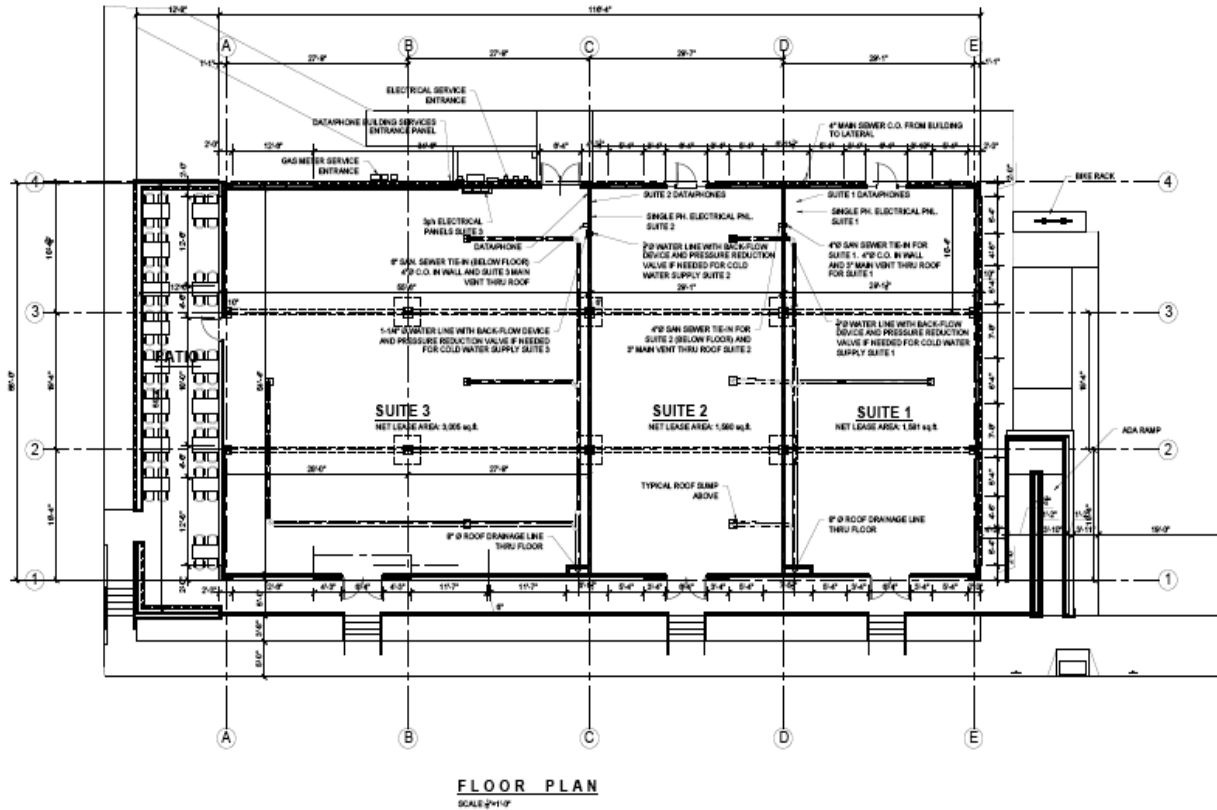
